Easy Auto Leasing Product Analysis

Google Adwords Analysis

Below are the keyword results for keywords related to Auto Leasing. The results are a bit pricy so you'll have to limit your daily clicks for an affordable ad campaign.

Based on overall price and daily clicks you're probably going to want to stick with the terms "Automotive" and "Lease."

Our most expensive CPC is "Lease a car" at \$2.67 and the cheapest is "Automotive" for \$1.39.

Based on these results your best value is going to be "Automotive." That term has excellent monthly searches, excellent daily clicks and the best price as well!

The worst terms here are "Lease a Car" and "Auto Lease," The former having a terrible price and neither of them having very many daily clicks. They may still be a good investment if only because that match the contents of the book perfectly.

These estimated prices seem high but they assume an "unlimited" budget. If you adjust your budget Google will let you keep your position and just give you fewer daily clicks for a smaller price.
